
Quick Start Guide

About

Your HomeSight EM200 Environmental monitor enables you to monitor real-time environmental temperature and humidity. This device also has the capability to monitor the light intensity, motion, and sound.

Your EM200 comes supplied with a quick start guide, 2x AA batteries, double-sided adhesive tape, and an M3 screw and plastic wall plug.


Front view

Preparing your EM200: Before you power on your EM200, ensure to pull out the battery insulation tab along the direction specified.




Mounting instruction


This product can be mounted to a wall with either the screw and wall plug or the double-sided adhesive tape provided with each unit.

Using screw and wall plug (supplied):

1. Drill a hole in the wall to the size of the wall plug and then insert the wall plug.
2. Secure the rear cover of your EM200 with the M3 screw as shown.



3. Slide the front cover of your EM200 onto the rear cover, as shown, until it is firmly in place.




Using double-sided adhesive tape (supplied):

1. Peel the backing from one side of the adhesive tape and affix to the rear cover of your EM200.
2. Peel the backing from the other side of the adhesive tape and press the EM200 firmly against the wall.

Replacing the batteries

1. Slide up the front cover of your EM200.
2. Use the black rubber ribbon to pull out the batteries.



3. Replace with 2 new AA batteries and then slide the front cover onto the rear cover until it is firmly in place.
